MATCH I: One 40-shot match consisting of two 5-shot - 2 ½ minute strings fired at each range by relay at Chickens-40 meters, Pigs-60 meters, Turkeys-77 meters, and Rams-100 meters.

MATCH II: Same as MATCH I.

AGGREGATE MATCH: Combined scores of MATCH I & MATCH II.

DAN HEALY SOUTHERN TRIFECTA: Combined scores of Florida, Louisiana, & Arkansas events.

Standard Rifle Match I & Match II will be fired on **Saturday**. **Hunter Rifle** Match I & Match II will be fired on **Sunday**. DAILY MATCH AND AGGREGATE AWARDS WILL BE AWARDED EACH DAY AT THE CONCLUSION OF THE RESPECTIVE MATCH FOR THE DAY.

The entry fee is \$75 for the first gun and \$25 for the second gun, *which includes meals, target setters, and door prizes*. Please indicate your current NRA classification as well as the number of persons who will be attending the Friday evening meal. Entries will be accepted on the day of competition until the range capacity is filled (96 competitors maximum). Each competitor must have an **UP-TO-DATE 2008 NRA Silhouette Rifle Classification Score Record Book**. Any competitor who does not have a book will be required to buy one from the Statistical Officer and compete in the highest available class for the entire match. If the 2008 book is incomplete in any manner, the competitor must provide His/Her 2007 NRA book or be prepared to compete in the highest available class. Competitors must fire on assigned banks and relays. Scorecards must be signed and turned in to Stat Office before following relay begins.

There will be awards in each class unless there is only one shooter entered in that class. In that case, he or she will be combined into the next higher class. All class awards will be based on the number of entries by April 15, 2008. A trophy will be given to the Open Winner, High Senior, High Lady, and High Junior.

SAFETY: All bolts or actions must be VISIBLY OPEN at all times except on the firing line AFTER the “READY” command has been given. **EMPTY CHAMBER INDICATOR RULE WILL BE STRICTLY ENFORCED!**
